
- 1) The price should be quoted on F.O.R. VNIT, Nagpur.



<ol style="list-style-type: none">1. Providing and placing Metal storage unit with sliding glass door having Overall Dimensions 900mm(W)x450mm(D)x1830mm(H). The top shall be Metal top (1 mm add in unit height).2. The Rigid Knock Down Construction, Back, Sides and Door shall be made from 0.7 mm high yield strength CRCA.3. Door arrangement shall have sliding door with top hanging arrangement to prevent derailment.4. Each door shall be provided with 2 plastic roller having steel ball bearing for smooth movement of door & less noise.
